VAMS § 140.330 Form 1. Petition to quiet title to land conveyed by county collector

COMES NOW Plaintiff and, for [his/her] cause of action against Defendant, states and alleges as follows:

[Jurisdictional Allegations]

- 1. On [Date], Plaintiff [Name], purchased [Describe land with particularity] from the county collector of [County] County, Missouri, for the sum of \$[Amount], the land being sold for the nonpayment of taxes.
- 2. On that date Plaintiff received a deed covering the land from the collector.
- 3. Defendant, [Name], claims some interest in and to the real estate, the nature of which claims is unknown to the Plaintiff and cannot be described herein except to state that [his/her] claims are adverse and prejudicial to Plaintiff.

WHEREFORE, Plaintiff [Name], prays for judgment quieting title in the subject real estate in Plaintiff as fee simple owner and forever barring Defendant, [Name], or for anyone on [his/her] behalf, from any right, title or interest in the subject real estate, and for Plaintiff's costs herein.

AUTHOR'S COMMENT

The Plaintiff is the purchaser of the land. Those persons listed as Defendants should include all who have, or claim to have, or appear of record in the county where the land is located to have, any interest in, or lien upon, the land in question.

For plaintiff to prevail in quiet title action, defendant must have at least some interest in the property. Quiet title statute allows broad joinder of defendants. Bellistri v. Ocwen Loan Servicing, LLC, 284 S.W.3d 619 (Mo. Ct. App. E.D. 2009), reh'g and/or transfer denied, (Apr. 6, 2009) and transfer denied, (June 30, 2009).
